



### **Child Safe Standards – Code of Conduct**

#### **Purpose**

To provide guidance to all employees and volunteers on appropriate standards of behaviour towards children and to document Omeo District Health's commitment to child safety and the Victorian Child Safe Standards. For the purposes of this policy, a child is an individual under the age of 18 years.

#### Target Audience

All staff, Directors, contractors and volunteers

# Guideline

We are committed to having an organisation that is safe for all children where child abuse and harm are not tolerated. Child safety is a priority under our Child Safety and Wellbeing Policy, and the prevention and reporting of abuse is supported and encouraged. All staff and contractors involved with our business are responsible for promoting the safety, wellbeing and empowerment of children. We recognise that discrimination can harm children and we treat all children with dignity and respect.

This Code of Conduct sets expectations about how staff and contractors should behave around children. This helps children engage safely with our organisation.

Having behavioural standards to manage risks to children is important. This Code of Conduct identifies positive child safe behaviours that we ask staff and contractors to demonstrate. It also identifies behaviours that we consider unacceptable and not permitted in our organisation.

Not following standards of acceptable and unacceptable behaviour is a breach of this Code of Conduct and may result in disciplinary or corrective action. This can include increased supervision, appointment to an alternative role, or suspension/termination from the organisation.

Should a contractor breach this Code of Conduct it will be dealt with by corrective action on a case-by-case basis.

Some behaviours on their own may not be a serious breach of the Code of Conduct but together may indicate a concerning pattern of behaviour that poses a risk to the safety of children. The standards of behaviour to be followed at all times are attached in Table 1 below.

Any breach of this Code of Conduct must be reported to Omeo District Health Chief Executive Officer or Director of Nursing. # Policy

breaches of this Code of Conduct may by law need to be reported to Victoria Police, or to the Commission for Children and Young People. Our Complaint Handling Policy provides more information about obligations to report matters to external authorities as well as describing protections and confidentiality provisions for anyone making a report.

#### PLEASE NOTE:

If any person in a position of authority within our organisation becomes aware of a substantial risk that a child may become the victim of a sexual offence committed by an adult associated with the organisation (for example, an employee or contractor), and they have the power or responsibility to reduce or remove the risk, then they must take all reasonable steps to do so. A person in authority who negligently fails to take appropriate action to address the risk may be charged with the criminal offence of 'failing to protect' and may face a term of imprisonment.

If an adult reasonably believes a sexual offence has been committed by an adult against a child under the age of 16, they must report it to Victoria Police by calling 000 or going to their local police station. Failure to disclose such information may be a criminal offence.
